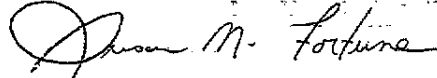

ARTICLES OF INCORPORATION

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be:

SURA, INC.

ARTICLE II - NATURE OF BUSINESS

The nature of business for which this corporation is organized is to engage in any activity of business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 100 shares of no par value common stock.

ARTICLE IV - REGISTERED OFFICE ADDRESS

The street address of the initial registered office of the corporation shall be 735 N. Thornton Avenue, Orlando, Florida 32803; and the name of the initial registered agent of the corporation at that address is SUNIA DEL CARMEN PIERMONT.

ARTICLE V - TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address shall be 735 N. Thornton Avenue, Orlando, Florida 32803.

ARTICLE VII - PREEMPTIVE RIGHTS

Shareholders of the corporation shall have preemptive rights to acquire their pro rata share of stock of the corporation for all issues of any class of stock of the corporation, no matter when authorized, and for whatever consideration is contemplated to be received by the corporation, including but not limited to cash, other property, services, the acquisition of other corporations shares or property through merger or the extinguishment of debt.

ARTICLE VIII - SHAREHOLDER MANAGEMENT

The corporation shall be operated by the Shareholders in lieu of the Board of Directors.

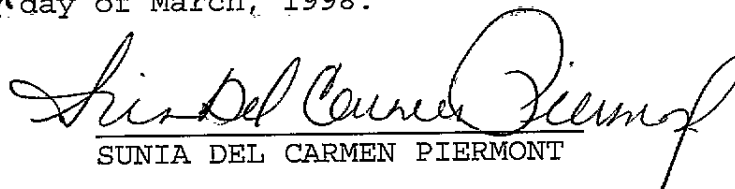

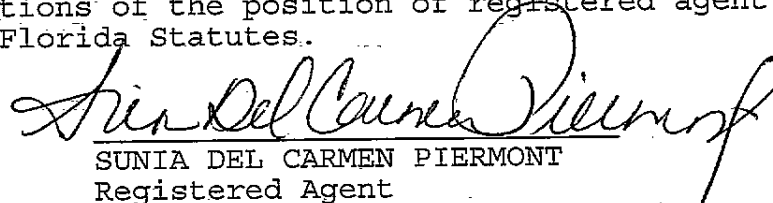
