The undersigned, for the purposes of engaging and organizing a corporation under the laws of the State of Florida, does hereby associate himself and adopt the following Articles of Incorporation for such corporation:

I. **NAME**: The name of the corporation shall be **HESSLER & ASSOCIATES, INCORPORATED**, and it is to be located at 297 Brockway Lane, Brooksville, Hernando County, Florida 34601.

II. **BUSINESS PURPOSE**: The nature and purpose of the corporation will be to own and operate an executive recruiting business and all other activities associated with the business. 



