The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I

#### NAME

The name of the corporation is Miranda Farms, Inc. and its address is c/o Spencer and Klein, P.A., Suite 1901, 801 Brickell Avenue, Miami, Florida 33131.

#### ARTICLE II

#### DURATION

The duration of the corporation is perpetual.

# ARTICLE III

#### PURPOSE
