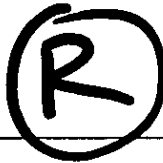

Officers of the Department of State:

I am respectfully requesting a waiver of the additional late fee that I owe due to the first notice being unseen by me, the bill payer: my husband does not know the importance of such documents, and by the time the second notice came, I was too overwhelmed to know what to do. The following explanation of why we need this hardship request fulfilled may shed some light on our desperation.

My husband, Ray, and I refinanced our home with a \$50,000 equity loan in March of 1998. (*The house would have been fully paid for in November of 1999.*) Our loan was used to open a well-researched business venture in the field of home inspection. Ray took the full home inspection training coursework in Bethesda, Maryland. We hired an attorney and an accountant, incorporated as Advantage Home Inspection Team, Inc., and signed a year's lease on a relatively inexpensive office in a convenient, well-exposed location. We joined the necessary organizations for credibility, logo use, etc., bought a reasonable amount of advertising in the Real Yellow Pages, and produced our own signs, brochures, business cards, and letterhead. Sounds great so far, right? Well, shortly thereafter our faith was challenged.

Ray had been feeling ill and finally went in for tests in late April of 1998 (1 month after our start-up costs were invested) The tests confirmed that he had 2 malignant tumors in his colon. On May 7, 1998, he had cancer surgery; he was out of commission the rest of the year with surgery to install a Port-a-Cath and chemotherapy through Christmas of that year. His health has been very slowly improving, but his strength and stamina is still only fair. Then, when we thought Ray would be able to work full time again, he began waking up in the middle of the night with searing pains running the length of his left arm. This eventually required a 5-½ hour surgery on his shoulder in the summer of 1999. He is still in physical therapy to regain full use.

Since then, our life savings has been depleted, as well as my \$10,000 IRA, and we finally had to fully refinance our home in July 1999 for \$98,471.48. We did not file bankruptcy *only* because we *could* refinance our house and we believe in paying our debts.

Ray performs inspections when he is able. However, as you can see on the UBR Form, we have had to give up our office and Ray now works out of our house. We have invested so much in this business that I cannot tolerate its demise. To top it off, my daughter decided to live with her dad, a lawyer, so she could live a more affluent life, and that took one-third of our "income" away in July 2000.

If I must come up with \$600 or \$700, I'll have to go over my credit limit, which could adversely effect the mortgage loan I've applied for to allow us to move into smaller, less expensive housing.

Your time spent in consideration of this matter will be greatly appreciated.
