1. The Articles of Incorporation FMB Funding, Inc. (the "Corporation") are amended and restated as follows:

2. The following amended and restated Articles of Incorporation were adopted by the shareholders and members of the board of directors of the corporation on 6/22/98

ARTICLE 1

NAME

The name of this corporation is: FMB Daytona Beach, Inc.

ARTICLE 2

DURATION

The duration of this corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of the articles of incorporation by the Department of State of the State of Florida.

ARTICLE 3

GENERAL PURPOSES

The general purposes for which this corporation is initially organized are to engage in any or all lawful business for which corporations may be incorporated under Florida law.

ARTICLE 4

SHARES

The aggregate number of shares which the corporation shall have authority to issue is 100 shares of common voting stock having a par value of \$1.00 per share.

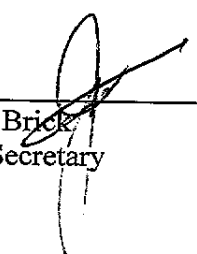
The number of directors may be changed from time to time in accordance with the bylaws.
