### ARTICLES OF INCORPORATION OF DESTIN BUYER'S REALTY, INC.

The undersigned, acting as incorporators of a corporation pursuant to the Chapter 607, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

### ARTICLE ONE NAME

The name of the corporation is DESTIN BUYER'S REALTY, INC.

## ARTICLE TWO CORPORATE DURATION

The duration of the corporation is perpetual unless dissolves according to law. Exporate existence shall commence at the time these Articles of Incorporation are filed by the Department of State.

#### ARTICLE THREE PURPOSE OR PURPOSES

The purpose or purposes for which this corporation is organized is:

(1) To engage in any necessary and lawful business activity allowed by law.

## ARTICLE FOUR TAX ORGANIZATION

The Shareholders hereby elect to form a Subchapter S corporation as defined by the United States Code.

### ARTICLE FIVE CAPITALIZATION

The number of share of stock that this place corporation is to have outstanding at any one time is one hundred (100) and shall have no par value.

The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than 35 persons. Stock will be issued and transferred only to (i) natural persons, (ii) estates, or (iii) a trust defined in Section 1361 (c)(2) (or its successor section) of the Internal Revenue Code. In addition, no stock shall be issued or transferred to a nonresident alien.

### ARTICLE SIX REGISTERED OFFICE AND AGENT
