ARTICLE ONE

The name of the corporation is **EUROPEAN MGM, INC.** The principal address of the corporation is: 3325 GRIFFIN ROAD, SUITE 218, FT. LAUDERDALE, FLORIDA 33312.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE


ARTICLE EIGHT
