OF

Article I - Name

The name of this corporation is **PILOT ISLAND PUBLISHING, INC.** whose address is 123 S. Woodland Street, Winter Garden, FL 34787.

Article II - Duration

This corporation shall have perpetual existence unless dissolved according to law, commencing upon execution of the Articles of Incorporation.

Article III - Purpose

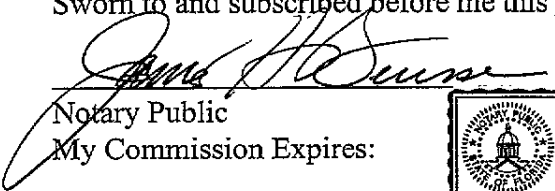

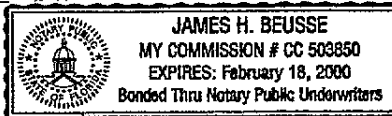

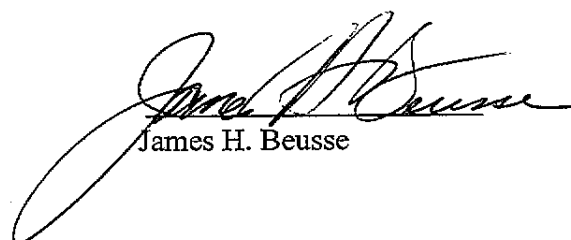
