The undersigned incorporator Frederick B. Isler, hereby forms PANHANDLE PRODUCE, INC., hereby forms a corporation for profit under the Florida General Corporation Act and other laws of the State of Florida.

1. NAME OF CORPORATION AND INITIAL ADDRESS: The name of this corporation shall be PANHANDLE PRODUCE, INC. and its address is 1301 Everitt Avenue, Panama City, Florida 32401.

2. TERM OF EXISTENCE: This corporation shall exist perpetually unless dissolved according to law.

3. GENERAL PURPOSE: This corporation may transact any or all lawful business for which corporations may be incorporated under the laws of the State of Florida and shall have those general powers conferred upon corporations under the laws of the State of Florida.

4. CAPITAL STOCK: The aggregate number of shares of capital stock which this corporation is authorized to issue is Two Thousand (2,000) par value of Fifty Cents (\$.50) per share. The stock will be divided into two classes: Class A Stock - 1,000 shares at \$.50 per share and Class B Stock - 1,000 shares at \$.50 per share.

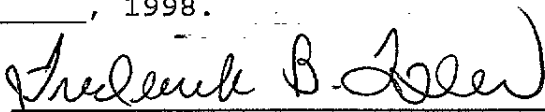

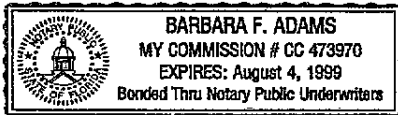

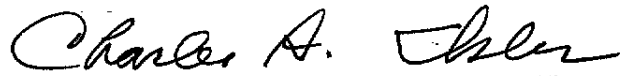
