The undersigned does hereby execute, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

The aggregate number of shares which the corporation shall have authority to issue shall be as follows:


ARTICLE X. PREEMPTIVE RIGHTS

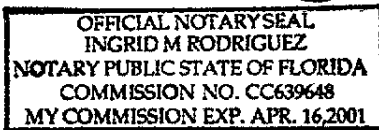

This right shall be deemed waived by any Shareholder who does not exercise it and pay for the shares or other securities preempted within thirty (30) days of receipt of a notice in writing from the corporation stating the price, terms and conditions of the issue of the shares and inviting it to exercise its preemptive rights. This right may also be waived by affirmative

written waiver submitted by the Shareholder to the corporation with thirty (30) days of receipt of the notice for the corporation.



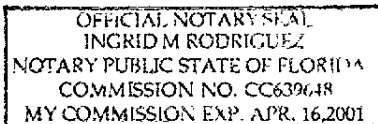
