# ARTICLES OF INCORPORATION OF FAF GROUP IV, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I

#### Corporate Name and Principal Office

The name of this corporation is FAF GROUP IV, INC. and its principal office and mailing address is 1245 Blackrush Drive, Tarpon Springs, FL 34689.

#### ARTICLE II

#### Commencement of Corporate Existence

The corporation shall come into existence on March 18, 1998.

#### ARTICLE III
