ARTICLES OF INCORPORATION OF

Spectrum Coatings Corporation

The undersigned incorporators of these Articles of **Spectrum Coatings Corporation**, each a natural person competent to contract, associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

NAME: The name of this corporation is Spectrum Coatings Corporation

ARTICLE II

CORPORATE PURPOSES: The corporate purposes are:
