The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is G. Cor Realty, Inc. and its principal office at 617 Horatio Street, Suite B, Tampa, Florida 33603 and mailing address is P.O. Box 18262, Tampa, FL 33679-8262.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on March 16, 1998.

ARTICLE III

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.
