**ARTICLES OF INCORPORATION
OF

The undersigned, being a natural person, does hereby act as incorporate in adopting the following Articles of Incorporation for the purpose of forming a corporation under the Florida Business Corporation Act:

ARTICLE I NAME

The name of the corporation (hereinafter called the corporation) is J. Hurtado Inc.,

ARTICLE II PRINCIPAL OFFICE
