ARTICLES OF INCORPORATION

OF

UNIVERSAL CONSULTING TECHNOLOGIES.

I, the undersigned, hereby make the within Articles of Incorporation for the purpose of becoming incorporated and being a corporation under and by virtue of the laws of the State of Florida under the following proposed charter:

<u> ARTICLE I - NAME/ADDRESS</u>

The name of this corporation shall be UNIVERSAL CONSULTING TECHNOLOGIES, INC., and it's business shall be carried on in the State of Florida and such other states and foreign countries as may be agreed upon, and it's principal place of business shall be 3000 Gulf To Bay Blvd., Suite 206, Clearwater, FL 33759 or such other place as from time to time is designated.

ARTICLE II - PURPOSE

This corporation shall be authorized and permitted to engage in any activity or business permitted under the laws of the United States and the State of Florida.
