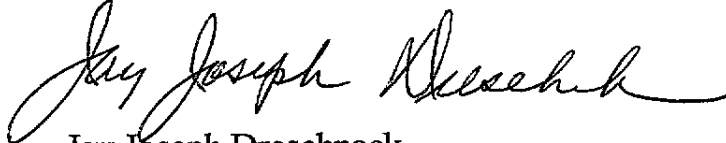

The aggregate number of shares which the corporation shall have authority to issue is 100 shares of no par value.

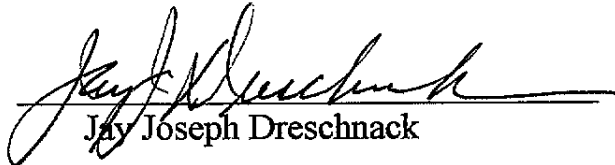
ARTICLE FIVE

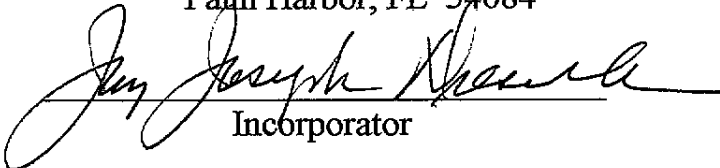
ARTICLE EIGHT

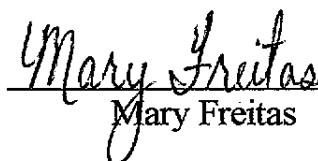
