

ARTICLE ONE - NAME & ADDRESS

The name of the Corporation is SNYDER DOOR INSTALLATIONS, INC., and the principle place of business of this corporation shall be: 4405 21st Street North, St. Petersburg, FL 33714.

ARTICLE TWO - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida. This Corporation shall have all of the powers and privileges general and additional enumerated and conferred upon Corporations generally by Chapter 607 (also referred to as the Florida General Corporation Act), Florida Statutes 1977 and any amendments thereto.

ARTICLE THREE - CAPITAL STOCK
