The undersigned incorporator hereby executes, acknowledges and files with the Florida Department of State the following Articles of Incorporation (the "Articles") for the purpose of organizing a corporation pursuant to Chapter 607, Florida Statute (the "Act").

ARTICLE I - Name

The name of the corporation is M.T.M.L., INC.

ARTICLE II - Principal Office

The initial principal place of business or mailing address of the Corporation shall be 13205 U.S. Highway 1, Ste.509, Juno Beach, Florida 33408.

ARTICLE III - Term of Existence

The Corporation shall exist as of March 18, 1998. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State, of the State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

Article IV - Nature of Business

The corporation is organized for the purpose of transacting s purchases, sales and leases of motorcycles and any and all other
