# Articles of Incorporation of Brooks Nicole Miller, Inc.

I, the undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

The name and address of the initial director of the corporation is **Debra Vila** of **343 Plaza Real, Boca Raton, Florida 33432**.

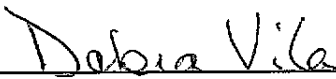
**ARTICLE IX**

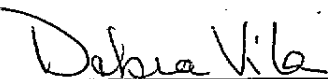

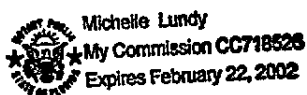
