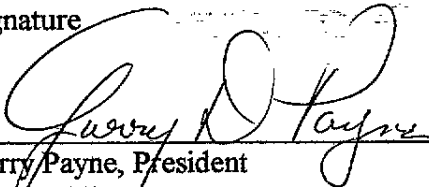

FIRST: Article I is hereby amended to change the name of the corporation to Groomobile, Inc.

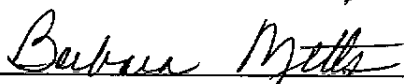
SECOND: If an amendment provides for an exchange, reclassification or cancellation of issued shares, providing for implementing the amendment if not contained in the amendment itself are as follows:

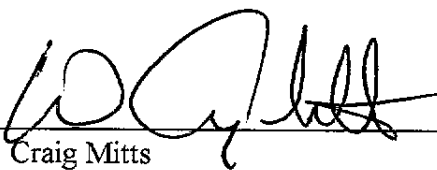
