The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I - Name

The name of this corporation is TIE Audio Engineering, Inc.

Article II - Principal Place of Business

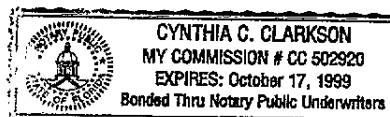
