ARTICLES OF INCORPORATION

OF

KIARA DESIGNS COMPANY



ARTICLE I - NAME:

The name of this corporation is: KIARA DESIGNS COMPANY, hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:

The power to adopt, alter, amend or repeal the By-Laws shall be vested in the Board of Directors and the shareholders.


ARTICLE X - SECTION 1244 STOCK:
