

ARTICLES OF INCORPORATION

OF

REYNA DEVELOPMENT, INC.



ARTICLE I - NAME:

The name of this corporation is: REYNA DEVELOPMENT, INC hereinafter referred to as the "Corporation".

ARTICLE IX - BY-LAWS:


The power to adopt, alter, amend or repeal the By-Laws shall be vested in the Board of Directors and the shareholders.
