We, the undersigned, hereby associate ourselves for the purpose if becoming a corporation under the laws of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I - NAME AND ADDRESS

The name of this Corporation shall be PAR CIRCLE SOUTH, INC., and the mailing address and the address of the principal office shall be 23 NW 33 Court, Gainesville, Florida 32607.

ARTICLE II - TERM

This Corporation shall have perpetual existence unless sooner dissolved according to law. This corporation shall begin business on the day of the filing of these Articles of Incorporation.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting

any or all lawful business, including, but not limited to, the following:

(a) To do any and all acts and things, and to exercise any and all other powers conferred by the laws of Florida upon corporations formed under the provisions of Chapter 607, Florida Statutes, 1991, as amended, and which now or hereafter may be authorized by law.

(b) To have and exercise all powers necessary or convenient to effect its purposes.

#### ARTICLE IV - STOCK

The maximum number of shares of stock outstanding at any time shall be five hundred (500), with par value of One Dollar (\$1.00) per share, all of one class, common, participating voting stock.

#### ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which such stock is offered to

others.

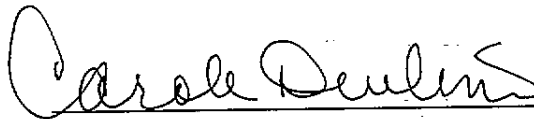
