# ARTICLES OF INCORPORATION

OF

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

#### **ARTICLE I**

The name of the corporation is **TRANSPORTATION MANAGEMENT RESOURCES, INC.** 

## ARTICLE II

The corporation is to commence it existence on the date of filing and acknowledgment of the Articles of Incorporation and shall exist perpetually thereafter until dissolved according to law.
