# ARTICLES OF INCORPORATION OF 98 MAR 23 PM 2: 19 GLOBAL CURRENCY CONSULTANTS, INCORPORATION TAILAHASSEE, FLORID

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE I

The name of the corporation shall be Global Currency Consultants, Inc.

#### ARTICLE II

The corporation shall have the power to engage in any lawful activity for which corporations may by organized under the Florida Business Corporation Act.

# ARTICLE III

The aggregate number of shares that the corporation shall have authority to issue and to have outstanding at any on time is 1000 shares. All such shares shall be of a single class, designated as common with a par value of \$0.01.

#### ARTICLE IV
