ARTICLE I - NAME

The name of this corporation is GOLD COAST WIRELESS, INC.

ARTICLE II - PRINCIPAL OFFICE

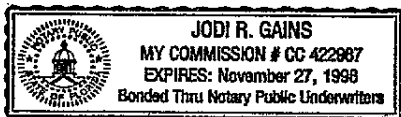
