## ARTICLES OF INCORPORATION

### ARTICLE I - NAME

The name of this corporation is PLA Funding Corp.

### ARTICLE II - PRINCIPAL OFFICE

### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

### ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 5,000 shares of \$1.00 par value common stock which shall be designated as "Common Shares".
