

ARTICLE ONE. NAME

The name of the corporation is TOPSCO, INC.

ARTICLE NINE. AMENDMENT



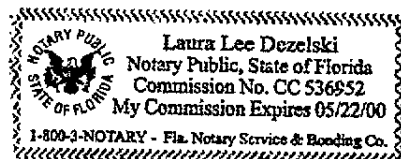


