I, the undersigned natural person above the age of twenty-one (21), hereby form a stock corporation under the applicable provisions of Florida law and adopt articles of incorporation for such corporation as follows:

ARTICLE I. NAME

The name of the corporation is: International Taekwondo Academy, Inc.

ARTICLE II.

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the Florida General Corporation Act, other than the banking business, the trust company business or the practice of a profession permitted to be incorporated in the State of Florida.

ARTICLE III. DURATION

The period of duration is perpetual.

ARTICLE IV. CAPITALIZATION

The corporation shall have authority to issue 1,000 shares of common stock with no par value for each share. The stock of the corporation shall not have any preferred or cumulative rights.


