ARTICLES OF INCORPORATION OF HIGHLANDS INDEPENDENT SUCCESSOR BANK

The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I

EFFECTIVE DATE

4-1-98

The name of the corporation shall be Highlands Independent Successor Bank and its initial place of business shall be at 2600 U.S. Highway 27 North, in the City of Sebring, County of Highlands and the State of Florida.

ARTICLE II

This corporation shall be organized as a successor institution in accordance with Section 658.40(4), Florida Statutes.

ARTICLE III

<u>Section 1</u>. The total number of shares authorized to be issued by the corporation shall be 100, the par value of which shall be \$1.00.

Section 2. The corporation shall begin business with at least \$1.00 in paid-in capital stock to be divided into one share of the par value of \$1.00, which shall be paid in cash. The corporation will not begin business with any surplus or undivided profits.

ARTICLE IV

The term for which said corporation shall exist shall be one (1) year.

ARTICLE V
