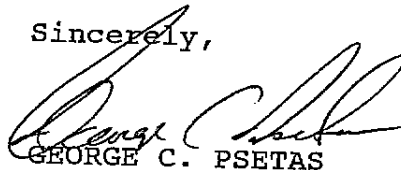

ARTICLE I. NAME

ARTICLE II. NATURE OF BUSINESS
