ARTICLES OF INCORPORATION
OF

CAPITAL STOCK

No contract or other transaction between the corporation and any other corporation, association, person or firms, in the absence of fraud, shall be affected, invalidated, voided or voidable because one or more of the Directors or officers or stockholders of the corporation, is or are interested in such contract or transaction as a Director or officer or stockholder of the other corporation, or association or otherwise individually or jointly a party to any such contract or transaction with this corporation, or in which this corporation is interested; and no Director or officer of this corporation shall incur any liability by reason of the fact he is or may be interested in any such contract or transaction. A Director of the corporation may vote upon any such contract or other transaction between the corporation and any officer, Director or stockholder thereof or any corporation, association, person or firm in which such officers, Directors or stockholders are interested, including the Director creating such vote.

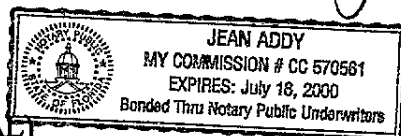
