PURSUANT TO Chapter 607 of the Florida Statutes, the undersigned, acting as sole incorporator of **ACCESSIBILITY LIFTS, INC.** hereby adopts and files the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of the corporation is **ACCESSIBILITY LIFTS, INC.**

**ARTICLE II
DURATION; EFFECTIVE DATE**

This corporation shall exist perpetually, commencing as of March 25, 1998.

**ARTICLE III
PURPOSES**

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

**ARTICLE IV
PRINCIPAL OFFICE AND MAILING ADDRESS**

The address of the principal office and the mailing address of the corporation is 745 Ashley Lane, Orlando, Florida 32825. The location of the principal office shall be subject to change as may be provided in bylaws duly adopted by the corporation. And the corporation may have other offices, agencies and branches at such places as may be determined by the Board of Directors.

**ARTICLE V
SHARES**

The number of shares which the corporation shall have authority to issue is One Thousand (1,000), consisting of a single class of common stock, One Dollar (\$1.00) par value per share; however, it shall at no time be necessary to issue stock certificates.

ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT

The name of the initial Registered Agent of this corporation and the street address of the initial Registered Office are as follows: Nora Riva Bergman, P.A., 360 Central Avenue, Suite 1220, St. Petersburg, Florida, 33701.

ARTICLE VII
INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws, but shall never be less than one (1). The name and address of the initial director of this corporation are:

AMENDMENT

This corporation reserves the right of amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE X
BYLAWS

The initial Bylaws shall be adopted by the Board of Directors. The power to alter, amend, or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the Shareholders.

ARTICLE XI
INFORMAL SHAREHOLDER ACTION

The holders of not less than a majority of the issued and outstanding shares of the voting stock of the corporation may act by written agreement without a meeting, as provided in Florida Statutes 607.0704 and the Bylaws.

ARTICLE XII
PREEMPTIVE RIGHTS

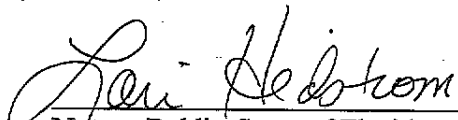
Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation stating the prices, terms and conditions of the issue of shares and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
