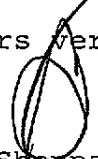

ARTICLE I  
Name and Principal Office

The name of this corporation is AIR MASONRY, INC. The principal place of business and mailing address of this corporation is 825 Southeast Third Avenue, Ocala, FL 34470.

ARTICLE II  
Duration

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III  
Purpose

This corporation shall have two (2) directors initially. The number of directors may be either increased or diminished from time to time by the bylaws. The names and addresses of the initial directors are:

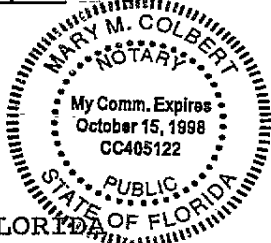
