ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. Name. The name of this corporation is ANTHONY AVELLO AND ASSOCIATES, INC., a Florida corporation.

2. Principle Place of Business. The principle place of business for said corporation is 2425 Hollywood Blvd., Hollywood, Florida 33020.

3. Duration. The period of its duration is perpetual.

4. Purpose. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida; including providing residential and commercial liability analysis, communications and graphic design.

5. Capital Stock. The corporation is authorized to issue 100 shares, all of one class, at no par value.
