The undersigned, acting as incorporator of the captioned corporation, under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I
Corporate Name**

The name of the corporation is:

**ARTICLE II
Commencement of Corporate Existence**

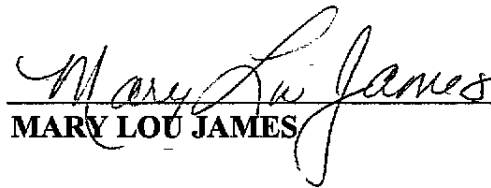
