The name of this Corporation is Harbour West Coast Management Group, Inc.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

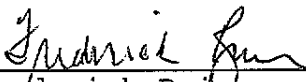

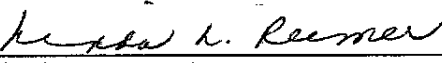
