

ARTICLES OF INCORPORATION Bradshaw & MacKenzie, Inc.



The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, Hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. The name of the Corporation shall be:
