

ARTICLES OF INCORPORATION
OF

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

I

The name of the corporation shall be *PROGRESSIVE ELECTRICAL SERVICES OF CENTRAL FLORIDA, INC.*. The principal place of business shall be 2634 Abalone Blvd., Orlando, Florida 32833.

II

The duration of this corporation is perpetual unless dissolved according to law.

III

The purposes for which this corporation is organized are:
