ARTICLES OF INCORPORATION

OF

BOB WADDLE ENTERPRISES, INC.

The undersigned, acting as Incorporator of BOB WADDLE ENTERPRISES, INC., under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME:

The name of the Corporation is:

BOB WADDLE ENTERPRISES, INC.

ARTICLE II. COMMENCEMENT OF EXISTENCE:

This Corporation shall have perpetual existence, commencing on May 1, 1998.__

ARTICLE III. PURPOSE:

The general purpose or purposes for which the Corporation is organized are as follows:

- (a) to perform consulting services for airports throughout the world; and
- (b) to transact any and all other lawful business for which business may be incorporated under the Florida General Corporation Act.

ARTICLE IV. AUTHORIZED SHARES:

The maximum number of shares that the Corporation is authorized to have outstanding at any one time is 1,000,000 shares of common stock having a par value of \$1.00 per share. The consideration to be paid for each share shall be fixed by the Board of Directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or service actually performed for the Corporation with a value, in the judgment of the Directors, equivalent to or greater than the full par value of the shares.

ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT:

ARTICLE VI. INITIAL BOARD OF DIRECTORS:

The Corporation shall have one initial director. The number of Directors may be either increased or diminished from time to time, as provided in the Bylaws, but shall never be less that one. The name and address of the initial director is:

Thereafter, every amendment shall be approved by the Board of Directors, proposed by them to the Shareholders, and approved at a Shareholders meeting by the holders of a majority of the shares entitled to vote thereon or in such other manner as may be provided by law.
