### ARTICLE ONE

The name of the corporation is IRE MANAGEMENT, INC..

ARTICLE EIGHT

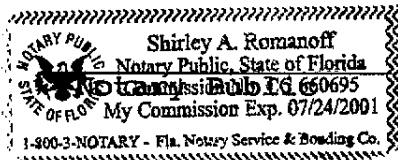
The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
