ARTICLES OF INCORPORATION of COFFEE SHOP BLENDS, INC



- 1. The name of the corporation is COFFEE SHOP BLENDS, INC.
- 2. The duration of the corporation is perpetual.
- 3. The initial address of the registered office in the State of Florida is 4613 Imperial Palm Ct., Largo, Florida 33771, County of Pinellas. The name of the Registered Agent at such address is Fenton E. Jones.
- 4. The purposes for which the Corporation is organized are.
- (a) To engage, without limitation, in any lawful activity for which corporations may be organized under the Laws of the State of Florida.
