CERTIFICATE OF INCORPORATION OF

FIRST: The name of the Corporation is "AMINAH'S SERVICES, INCORPORATED."

SECOND: Its principal office in the State of Florida is to be located at 3155 North West 42nd. Street, in the City of Lauderdale Lakes, County of Broward.

The registered agent in charge thereof is: **BARBARA ELAINE SMITH . at 11524 North West 1st. Street, Plantation, Florida 33325.**

THIRD: The nature of the business and objects and purposes proposed to be transacted, promoted and carried on, are to do any and all things herein mentioned, as fully and to the same extent as any natural persons could or might do, in any part of the world, viz.:

“ The purpose of the corporation is to engage in any lawful activity for which the corporations may be organized under the general Corporation Law of Florida.”

FOURTH. CAPITALIZATION: (Check the appropriate box and complete the capitalization method).

: : The corporation shall have the authority to issue Shares of Common Stock, each share to have no Par Value. The shares may be issued for the consideration expressed in dollars as may be fixed from time to time by the Board of Directors.

:X: The corporation shall have the authority to issue FIFTY Shares of Common Stock, each share to have a par value of \$1.00 : The shares may be issued upon such terms as the Board of Directors may from time to time authorize.

: : The corporation shall have the authority to issue two classes of stock. The classification and par value of each share of stock shall be as follows: _____ Shares of Common Stock with 1.00 Par Value, designated as Class 'A' Common Stock, with a Par Value of \$ 1.00 each share, designated as Class 'B' Preferred Stock.

Said preferred stock may be issued from time to time in one or more classes or series, with such dividend rates, voting rights, rights of conversion, rights upon dissolution or liquidation and with such designations, preferences and relative participation, optional or special rights or qualifications, limitations or restrictions thereof, as shall be determined by resolution adopted by the Board of Directors at the time such stock is issued.
