ARTICLES OF INCORPORATION

OF

CARGO Properties Inc.

The undersigned suscribe to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of this Corporation is CARGO Properties Inc. and its initial post office address and its principal office for the conduct of business is 21 North Military Trail, Suite "N", West Palm Beach, Florida 33415.

ARTICLE II

This Corporation shall exist perpetually.

ARTICLE III

This Corporation is organized for the purpose of transacting any and all lawful business.

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE XI
