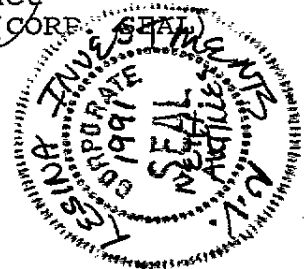

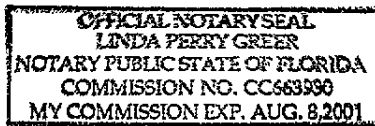


ARTICLE VIII


