## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation?

Act, adopts the following Articles of Incorporation:

#### ARTICLE I CORPORATE NAME

The name of the corporation shall be Stage-1 Talent, Inc. and the corporations principal address shall be 12798 Forest Hill Blvd. Suite 102, Wellington, Fl. 33414.

#### ARTICLE II TERMS OF EXISTENCE

This corporation shall have perpetual existence.

# ARTICLE III NATURE OF BUSINESS AND POWERS

The purposes for which the corporation is organized are to engage in the business of international trading, import, export, sales of goods, purchase of goods, and the general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the United States of America and the State of Florida.

## ARTICLE VIII AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. The shareholders shall have the power to adopt,, amend, alter, change or repeal the Articles of Incorporation when proposed and approved at a stockholders meeting, with not less than a majority vote of common stock.

## ARTICLE IX PRE-EMPTIVE RIGHTS

The holders of the common stock of this corporation shall have the pre-empive right to purchase, at prices, terms, and conditions that shall be fixed by the Board of Directors, such of the shares of stock of this corporation as may be issued for money (money or any property or services) from time to time, in addition to the stock authorized by the corporation.
