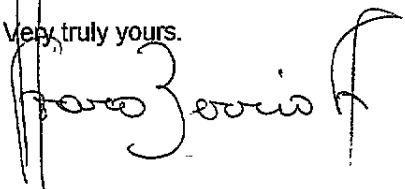

ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

3. The corporation shall have the authority to issue 1,000,000 shares of common stock, in class only, each with a par value of \$0.001.

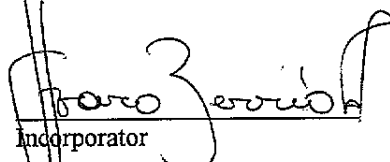
4. The registered agent of the corporation is Alvaro Berrio-Caratt and the registered address is 618 West 36th St., Hialeah, FL 33012.

The number of directors may be raised or lowered by amendment of the bylaws of the corporation but shall in no case less than one.

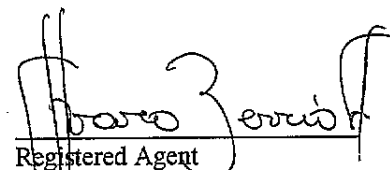
6. The incorporator of this corporation is Alvaro Berrio-Caratt whose address is 618 W. 36th St., Hialeah, FL 33012.
