ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Corporation is 100 Degrees East Investment Group, Inc., and its principal office or mailing address is 5125 Willow Leaf Drive, Sarasota, Florida 34241.

ARTICLE 2: DURATION

This Corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.
