ARTICLES OF INCORPORATION

OF

FELGER AND POLLEY, P.A.

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles Of Incorporation.

ARTICLE I - NAME

The name of this Corporation is FELGER AND POLLEY, P.A., a professional service corporation.

ARTICLE II - NATURE OF BUSINESS

The Corporation is a Professional Service Corporation which will provide medical services and medical related products to the public and businesses.

ARTICLE III - CAPITAL STOCK

The authorized capital of the Corporation shall be 100,000 shares of common stock at a par value of \$1.00 per share.
